I execute hardware and software configuration control and recommend material requisitions to maintain state-of-the-art database management systems. I perform daily evaluations of resources to minimize system downtime and ensure product quality. The development environment is Lotus Notes/Domino with an emphasis towards the web.

I was able to work on multiple high level contracts in several different roles. My experience ranged from creating a custom Customer Service Portal for Washington Gas & Light, to helping complete a Global Recruiting website for McKinsey & Company. I was also instrumental in creating a corporate tax extranet repository for PricewaterhouseCoopers (including a Japanese language site). All projects were created with Lotus Notes/Domino technologies and complemented with other internet technologies such as HTML, JavaScript and Macromedia Fireworks to name but a few. I was also able to participate in the Full-Lifecycle development for many of these projects. Internally, I was able to create a wireless network infrastructure that allows employees to work throughout the office space with the flexibility required by company directive.
